- Events may be combined if there are insufficient entries for any one event.
- The partner's name must be on the application if you are playing doubles.
- Entry fees must accompany applications.
- The Tournament Committee reserves the right to move players to a higher level.
- No allowances will be made after the draw is posted.
- Players are limited to two events - NO EXCEPTIONS.
